

1. Summary

Janet Dupuy Colley Professorship in International Studies

In 1999, the University of New Orleans was the beneficiary of a \$60,000 gift from the Colley family to fund the establishment of a Louisiana Board of Regents Endowed Professorship, the Janet Dupuy Colley Professorship in International Studies ("Janet Dupuy Colley Professorship"), in the College of Liberal Arts, Education and Human Development. The University used this private donation, along with matching funds from the Louisiana Education Quality Support Fund, to endow the Professorship.

John Dupuy Professorship in Pan American Studies

In 2003, the University of New Orleans was the beneficiary of a \$60,000 gift from the Colley family to fund the establishment of a Louisiana Board of Regents Endowed Professorship, the John Dupuy Professorship in Pan American Studies ("John Dupuy Professorship"), in the College of Liberal Arts, Education and Human Development. The University used this private donation, along with matching funds from the Louisiana Education Quality Support Fund, to endow the Professorship.

2. Support for the Repurpose and Renaming Request:

The donor's family, in conjunction with the University, would like to repurpose these two professorships to better align with the University's latest priorities and to rename the two professorships to appropriately honor their namesakes with areas of study that were of great interest to them. For Janet Dupuy Colley, it was the arts and for John Dupuy, it was business and international studies.

Since the establishments of these two professorships, events have also changed the focus and needs of the University, its Latin American Studies program and its new focus on the arts. The following changes have occurred affecting the two professorships:

• There is currently limited faculty with research interests directly related to Latin American Studies and current course needs are supplemented with adjuncts. However,

the University's International Studies program is robust and continues to enjoy successes in areas such as the Model UN.

The repurposing of the John Dupuy Professorship to International Studies would both reward and incentivize a current faculty member in the College of Liberal Arts, Education and Human Development whose instructional interests are aligned with international studies and also honor John Dupuy's area of interest.

This repurposing would also allow the currently unoccupied professorship to be filled.

In light of the repurposing, the donor's family would like to rename the John Dupuy Endowed Professorship in Pan American Studies as the John Dupuy Endowed Professorship in International Studies to reflect its broaden focus on international studies.

 With the University's increased emphasis on a distinct School of the Arts, the support from a repurposed Janet Dupuy Colley Professorship would focus on all forms of the arts. The repurposing of the Professorship would reward and incentivize a current faculty member in the College of Liberal Arts, Education and Human Development whose instructional interests are aligned with the arts and also honor Janet Dupuy Colley's area of interest.

The current focus area of this professorship, International Studies, will be moved to previously mentioned John Dupuy Professorship.

In light of the repurposing, the donor's family would also like to rename the Janet Dupuy Colley Endowed Professorship in International Studies as the Janet Dupuy Colley Endowed Professorship in the Arts to reflect its new focus on the arts.

The Board of Supervisors for the University of Louisiana System is authorized by HB 152 of the 2015 Regular Session relative to fees charged to students to establish fees and adjust fee amounts. The legislation includes the authority to impose per credit fees, to impose differential fees for certain programs exclusive of others, and to charge proportional amounts for part-time students and for summer sessions. Each institution will be required to establish a need-based financial assistance fund in an amount not less than five percent of revenues realized by the institution from fees assessed pursuant to HB 152. HB 113 of the 2017 Regular Session of the Louisiana Legislature extended the authority of HB 152.

Northwestern State University requests approval to assess a \$96 per semester Health Services Fee for the Shreveport campus. Students, faculty, and staff on the Shreveport campus have expressed a desire to have a convenient affordable health clinic. The services provided will assist in the recruitment and retention of students along with a convenient economical method for preparing for clinicals.

This memo is to request approval from the ULS Board to provide health services on the Shreveport campus. Based on repeated comments from students, faculty and staff in Shreveport about the need for health services at that location, administrators there began investigating a way to provide services like those provided in Natchitoches.

What they found was a need for regular student health services as well as the need for specific health services like vaccinations and tests for students prior to clinical rotations. The result of a recent survey of students on the Shreveport campus indicated that most students were in favor of a health services project and the necessary fee.

Nursing administration proposes a \$96.00 per semester (fall, spring, & summer) charge. Charges will be assessed to any student taking one-hour Face to Face on the Shreveport Campus.

Expected enrollment and revenue:

 700 students = \$67,200

 Spring
 700 students = \$67,200

 Summer
 150 students = \$14,400

 Total Annual
 1,550 students = \$148,800

Justification:

Students in Shreveport need a convenient affordable health clinic. Such services help students succeed in nursing and support them to graduation. In addition, provision of pre-clinical vaccinations and testing gives our students a convenient and more economical method of preparing for clinicals. We believe that such a service meets our strategic plans in Nursing and the Student Experience to promote health and wellness. More importantly, we view this service as a direct aid in retention and recruiting. Finally, as this request is made under the provisions of HB 152, 5% of the revenue will be earmarked for need based students on the Shreveport campus, giving Northwestern State additional resources to assist needy students.
