

For Our Future Award

GENERAL PROGRAM GUIDELINES

APPLICATION: <u>ULSystem.edu/ForOurFutureAward</u>

The For Our Future Award is designed to assist academically qualified students in bridging the gap between mandatory tuition and fees and institutional scholarships, state scholarships, Pell grants, and Go Grants. The scholarship will be applied to the remaining balance of mandatory tuition and fees after all federal, state, and institutional aid is applied. The Award will provide up to a maximum of \$5,000 for full time students and \$2,000 for part time students per academic year (\$2,500 for full time/\$1,000 for part time per semester or the equivalent).

The Award will be granted to students who have a demonstrated and documented need. Entering freshmen should have a minimum 2.75 high school grade point average and undergraduate continuing students should have a 2.50 cumulative grade point average. Those receiving a full time award must earn 24 credit hours for each academic year. Graduate continuing students must have a 3.30 cumulative grade point average or other indicator of preparedness and be enrolled full-time along with earning 18 credit hours for each academic year. Adult learners that previously stopped out and have reenrolled will be evaluated with holistic consideration of applicant's capabilities, circumstances, experiences and potential.

(Individual members of the Board of Supervisors for the University of Louisiana System may establish more stringent requirements.)

Students attending graduate school must receive unconditional admission in order to qualify for the Scholarship. Retention of the scholarship shall be based on students maintaining "good standing" with their respective academic programs.

The Award is not applicable to contracted tuition or professional programs.

- 1. Scholarships are awarded for a full academic year unless awarded for a single semester/quarter only (fall, spring, and summer). If a student graduates or becomes ineligible, the scholarship may be awarded to another qualified student for the remainder of the academic year.
- Each member of the Board of Supervisors shall be authorized to award a total of seventeen (17) scholarships for the academic year with up to twelve (12) full time awards and the remaining part time awards. Each member is allotted one full time scholarship to each of the nine institutions with three additional full time scholarships to any institution in the University of Louisiana System. The student Board member shall be authorized to award nine scholarships (up to 6 full time with the remaining as part time awards) to any institution in the University of Louisiana System. The Board Chair shall be authorized to award thirty four scholarships with up to twenty four (24) full time awards with the remaining as part time awards. Chair is authorized up to two full time scholarships to each of the nine institutions and six additional full time scholarships to any institution. All board members are authorized to award five (5) part time scholarships to any of the nine institutions. Any scholarship not awarded by September 15 may be awarded by the System president in consultation with the Board of Supervisors Executive Committee.
- 3. The value of the For Our Future Award is up to \$2,000 for part time award or \$5,000 for full time award and cannot exceed the actual cost of mandatory tuition and fees. Any excess scholarship funds are not eligible to be refunded. Students are encouraged, but not required to live in on-campus housing.

- 4. Members of the Board of Supervisors, System office employees, and members of their respective immediate families are ineligible for the scholarships. (The immediate family is defined as children, brothers, sisters, parents, spouse, and parents of one's spouse.)
- 5. Members of the Board of Supervisors are prohibited from awarding scholarships to the following elected officials and members of their immediate families:
 - a. U.S. Senators
 - b. U.S. Representatives
 - c. Members of the Louisiana Legislature
 - d. Statewide Elected Officials

Students may lose their eligibility for a For Our Future Award if they:

- a. Exceed the maximum number of semesters, terms, academic years, or equivalent provided under the terms of the scholarship that are listed in these regulations.
- b. Fail to maintain the required scholastic average.
- c. Transfer to another institution in the University of Louisiana System. In the case of a demonstrated hardship, the System president in consultation with the Board of Supervisors Executive Committee may approve the scholarship transfer.

TERMS

Undergraduate students may receive the scholarship for a maximum of eight regular semesters, four summer terms or equivalent for online learning schedule.

Professional and graduate students may receive the scholarship for the number of academic years that are considered normal academic progress toward receiving a degree.

Awardees must reapply every year.

APPLICATION AND SELECTION PROCEDURES

- 1. To apply for a For Our Future Award students should complete the application form that is available on the University of Louisiana System website (www.ulsystem.edu/ForOurFutureAward).
- 2. Students must also include a personal statement with the application form. Personal statements are essays no greater than 750 words. A successful personal statement will allow an inside glimpse of the applicant's life experiences and accomplishments. The personal statement assists board members in understanding the student's personal circumstances, core interests, skills, and values.
