Dear Dr. McConathy,

As a member of the Louisiana Tech University faculty since 1995 and an academic director since 2005, I enthusiastically submit my application materials to you for the position of Dean of the College of Liberal Arts. I have committed most of my professional career to advancing the role, scope, and mission of this Institution. I have contributed to the development of our Architecture program and have led the School of Design as its founding director. Through my vitae and application package, I hope to demonstrate to you and the search committee that I have made important contributions, in both leadership and support roles, within my profession, my academic unit, our University, and our State. Through these experiences and years of service at Louisiana Tech, I believe that I have developed the understanding, aptitude, and ability to contribute effectively to the duties and descriptions of the advertised position.

There is no College as diverse as the College of Liberal Arts. I would contend, however, that this diversity cannot be fully leveraged without a sense of unity among our constituent parts. In order to reach its fullest potential, College of Liberal Arts must evolve into *something greater than* the aggregation of the humanities, the arts, and a collection of professionally-accredited programs. I believe that much more can be capitalized from our Schools and Programs to establish a clearer, more unified identity for our College. Establishing greater transparency and engaging in regular communication among our Directors and Chairs will assist in establishing a sense of what we share as a College, rather than what differentiates us as individual academic units. This challenge of creating a refreshed identity for the College of Liberal Arts is vital to any future collective vision as an academic entity and as a meaningful contributor to our University. I believe this challenge is also very achievable through open communication and consensus building. I can unequivocally state that there is much embodied energy that exists within our College of Liberal Arts that has yet to be revealed: it simply needs the opportunity to develop through listening, supporting, and being willing to try something new. If provided this opportunity, our College will become the center of the unparalleled educational experience our University aspires.

Supported by a common identity, I envision the possibility for more transformative, interdisciplinary scholarship and pedagogy for our faculty, students, and partners in the College of Liberal Arts. By learning of the contributions from our colleagues and building a sense of common purpose and trust across the College, collaborative initiatives will flourish both within the College and beyond. Through the nurturing of interdisciplinary programs and coursework, I foresee opportunities, at small and large scales, of growth, of renewed energy, and of optimism. I feel that there have been past challenges, acrimony, and complacency that have contributed to a miscasting of our highest potential as a College. The College of Liberal Arts can reach that potential through a renewed spirit of collegiality within our Programs, a reengaged sense of community across our Schools, and a collective purpose beyond our individual academic silos.

My education and training as an architect and designer have engrained a sense of optimism and purpose in how I think about and approach my work. It is because of this optimism that I have applied for the position of Dean. I believe I have demonstrated an ability to contribute to the building of the College of Liberal Arts that becomes not only the academic heart of our University but also a model for our State. I am keenly aware of the unique context our University offers as both a place of learning and as an academic community of thinkers, researchers, teachers, and professionals. Over the years, I have worked productively with many individuals, committees, councils, and groups, both within and outside of our University, to bring value, influence, and opportunity to this Institution. I know my colleagues in the College of Liberal Arts (and many know me!). I hope through my time and attention to my roles at our University that I have illustrated my unwavering commitment to the College of Liberal Arts and this extraordinary community. I would value the chance to further convey my interest in this position, if the opportunity allows.

Currently planning a facilities enhancement to the FJ Taylor Visual Arts Center to establish a new digital game design studio space.
  - Initiates the collaborative agreement between the School of Design and MedCamps of Louisiana (Caleb Seney, Executive Director) to utilize Camp Alabama (Sibley, LA) as the site for projects designed, fabricated, and constructed by the Design/Build Architecture Studios (2016-present). Seven projects involving over 150 architecture students have been constructed to benefit the mission of MedCamps of Louisiana: to improve the health and wellness of people living with chronic illnesses and disabilities through unique recreational and camping experiences (Professors Robert Brooks and Brad Deal, Design/Build faculty)
  - Supports the establishment of the Experiential Design (ExD) Studio (2018-present), a collaborative design studio with the SOD's Graphic Design and Interior Design Programs to research and develop hospitality-based projects for upper division undergraduate students (Professors Marla Emory and Tom Futrell, ExD faculty). Supported two crowdfunder initiatives, raising over \$10000 in funds for the ExD studio for travel, materials, and technology
  - Coordinates with Architecture faculty to create two "tracks" for a junior-level studio sequence (ARCH 325 and 335). Track one will serve as the Design/Build studio track; track two will serve as the digital design/virtual reality/augmented reality studio track (2021)

  - Establishes a new collaborative Letterpress Studio (2021) with Studio Art and Graphic Design in the FJ Taylor Visual Arts Center through the purchase of a vintage Vandercook Universal One Proof Press (one of only 2500 Vandercook presses worldwide), the acquisition of type and

- equipment from the former University printing press and other sources, and support of workshops and training by letterpress artists (Professors Frank Hamrick and Jake Dugard, letterpress faculty)
    - Creates the ART 320 – Digital Painting as an innovative course addition to the Studio Art course catalog with Nick Bustamante; assisted in the procurement of digital tablets to support the course from Justin and Jeanette Hinkley (2016)

It is with pleasure that I invite you to accept the position of Provost & Senior Vice President for Academic Affairs at The University of New Orleans. This appointment is 100% of full time and will carry an annual fiscal year salary of \$250,000.00 effective January 1, 2023. I am also offering you tenure and the academic rank of Full Professor in the School of Education in the College of Liberal Arts, Education and Human Development. If you return to faculty, your 9-month academic salary will be determined in accordance with Administrative Policy AP-AA-37.

In addition, we are offering you a up to \$15,000.00 relocation incentive to be paid from foundation funds. In accordance with IRS regulation, this will be taxable income to you. Additionally, we will pay for up to two on-boarding visits between today and December 16, 2022, payable from foundation funds.

The offer is contingent upon a satisfactory background check, as well as receipt and review of official transcripts, if transcripts are applicable. This offer is also subject to final approval of the University of Louisiana System, Board of Supervisors. This position is unclassified, meaning it is not governed by the rules of the Louisiana Civil Service Commission. All unclassified employees serve at the pleasure of the Board. Continued employment is contingent upon availability of funds and satisfactory performance. As an exempt salaried employee, you will not be eligible for overtime pay.

In addition, Act 264 of the 2013 Regular Session of the Louisiana Legislature requires all unclassified employees earning in excess of \$100,000 annually to provide proof within 30 days of hire that they have a valid Louisiana Driver's license and that all vehicles registered in their name have been registered in this state. 
