University of New Orleans' request for approval of Memoranda of Understanding between the New Orleans Center for Creative Arts Culinary program (NOCCA – Culinary Arts) and the Lester E. Kabacoff School of Hotel, Restaurant and Tourism Administration at the University (UNO-HRT program).

#### **EXECUTIVE SUMMARY**

#### **Full-Day Program:**

Graduates of the NOCCA Culinary Arts program earn a Certificate of Artistry or Achievement in Culinary Arts upon the successful completion of four years of coursework at NOCCA.

This MOU establishes a clear pathway for NOCCA Culinary Arts program graduates to seamlessly transition into the UNO-HRT program, facilitating the transfer of credits earned during their NOCCA coursework.

Under this agreement, NOCCA Culinary Arts graduates holding certificates are eligible to receive up to 30 credit hours within the UNO-HRT program. The specific UNO courses eligible for credit transfer are detailed in the MOU.

To enhance the strength of this collaboration, both programs have devised engagement activities for their respective student bodies. NOCCA Culinary Arts students partake in a semesterly tour of the UNO-HRT program, which includes comprehensive presentations on the HRT program, UNO Admissions/Financial Aid, and culminates in culinary and classroom demonstrations, offering a firsthand experience of a day in the life of a UNO-HRT student. As a reciprocal gesture, UNO-HRT actively participates in NOCCA Culinary Arts career days, engaging with students on campus and contributing to their classroom activities.

This MOU not only solidifies the academic connection between NOCCA's Culinary Arts program and UNO's HRT program, but also fosters a meaningful exchange of insights and experiences between the two student communities.

#### Half-Day Program:

Under this agreement, students enroll in the NOCCA Culinary Arts program as half-day participants while maintaining their home high school affiliation. Successful completion of the NOCCA Culinary Arts program as half-day students earns them a Certificate of Artistry or Achievement in Culinary Arts.

Students in the Half-Day program may transfer a maximum of 30 credit hours to the UNO-HRT program. These credits encompass 13 hours from the NOCCA Culinary Arts curriculum, supplemented by eligible credit hours from their respective home high schools.

The remaining provisions of this MOU mirror those outlined in the Full-Day student MOU.

#### MEMORANDUM OF UNDERSTANDING BETWEEN NEW ORLEANS CENTER FOR CREATIVE ARTS (NOCCA) AND THE UNIVERSITY OF NEW ORLEANS SCHOOL OF HOTEL, RESTAURANT AND TOURISM ADMINISTRATION Effective – 2023-2024 Academic Year

#### PURPOSE

This Memorandum of Understanding (MOU) summarizes an educational partnership agreement between the New Orleans Center for Creative Arts (NOCCA), and the University of New Orleans (UNO) School of Hotel, Restaurant and Tourism Administration (HRT), to provide undergraduate educational opportunities for students who may attend both institutions. This agreement ensures that each institution serves the needs of students by providing them with appropriate and accurate transfer and advising information.

#### GOALS

The goals of this agreement are to:

- Provide an articulated credit program whereby NOCCA students may earn credits for UNO classes,
- Improve the transfer and advising process for the benefit of students attending both institutions,
- Develop an Expanded Course Articulation Crosswalk between the institutions,
- Identify personnel in each institution who will coordinate and serve as advisors for NOCCA students entering UNO,
- Improve collegiality and communication among the institutions' discipline faculty and administrators.

To achieve these goals, NOCCA and UNO hereby enter into the following agreement.

#### A. PROVISIONS FOR STUDENTS

- NOCCA students may earn a maximum of 30 credit hours that will be applicable to their degree program at UNO. The course matrix, found in Appendix A, provides the specific articulations between NOCCA courses and UNO courses. NOCCA students who believe that they have the background appropriate for advanced standing in courses not included in this matrix will be provided the opportunity to attain advanced standing through the normal UNO process following admission to the program.
- NOCCA students must meet the admission requirements in effect for beginning freshmen at the time of application in order to be admitted to UNO and receive articulated credit as outlined in this agreement.
- NOCCA students must follow normal application procedures prior to admission to the University of New Orleans. As part of this process, students must submit an official transcript from the New Orleans Center for Creative Arts. Students must indicate on their application that they attended NOCCA in order for course credit to be awarded. Application materials are available online at <u>https://www.uno.edu/admissions/apply</u>.
- Students in the NOCCA program who are degree seeking at UNO may be eligible for financial aid. Contact the Office of Financial Aid with eligibility questions. https://www.uno.edu/financial-aid

- NOCCA students must interview/audition/present their portfolio confirming mastery in order to receive credit for select courses.
- Students must receive a grade of A or B for NOCCA coursework and possess a Certificate of Artistry or Certificate of Achievement in their focus area in order to receive credit from UNO. Lab credit will not be awarded without corresponding lecture credit. A full-year course requires a grade of A or B in both semesters for credit to be awarded.
- Students will be awarded credit based on the course equivalencies and related requirements listed in this agreement (Appendix A). Course credit will be earned only and indicated with a "CR" on the UNO transcript. Thus, this course work will not be included in the cumulative grade point average calculations.
- Upon admission to UNO, students must have their NOCCA transcript evaluated by the UNO Office of Admissions. This should take place before the student registers to eliminate any problems with course credit.
- Degree and program requirements for NOCCA students who attend UNO and are granted course work under this agreement will be determined in the same manner as if their initial enrollment had been at UNO.
- NOCCA students pursuing the undergraduate degree at UNO must complete at least 25% of the semester credit hours required for the degree through instruction offered by UNO. One third of the credit hours required in the major, minor, or concentration must also be completed at UNO and can be included in the 25% degree requirement.
- Articulation of NOCCA credit is optional. A NOCCA graduate must inform UNO that s/he does wish to have their credit articulated.
- The President or College Counselor of NOCCA may recommend students for dual enrollment in UNO classes.
- This agreement applies to first-time freshmen and transfer students whose initial admission to UNO is for the Fall 2023 semester or after. This agreement does not apply to former NOCCA students whose initial admission to UNO occurred prior to Fall 2023.

#### **B. PROVISIONS FOR INSTITUTIONS**

- Faculty employed by NOCCA must meet stated professional credential requirements set forth by the Southern Association of Colleges and Schools Commission on Colleges which governs the acceptability of coursework taught and accepted for articulated credit by colleges and universities.
- NOCCA must submit a course portfolio, to include, but not limited to examinations and other course documents, for review by UNO annually or upon request.
- NOCCA will provide an opportunity for UNO faculty to observe course instruction.
- The institutions will engage in joint marketing efforts to promote the articulation partnership. Promotional efforts will include but are not limited to - links on respective Web sites for placement of articulation agreements, information in the University Catalog, and transfer information in other school/college publications.
- NOCCA will promote the UNO-HRT program to prospective students within their programs.
- The institutions will encourage meetings between the UNO and NOCCA discipline faculty and administrators. The Provost/VP for Academic Affairs or designee at NOCCA will direct these meetings

 The institutions will discuss mutually beneficial collaborations among faculty and will seek opportunities for such collaborations to develop.

#### C. TERMS

This agreement shall be effective on \_\_\_\_\_\_ and shall continue until terminated by either party giving one-year written notice to the other party in order to protect students enrolled in the dual enrolment program.

Any changes to this MOU must be in writing and delivered by certified mail or by personal delivery to the person to be notified.

#### HRT 3002 - HRT Work Experience (1 credit hour):

The School of HRT will accept hospitality industry work experience hours completed by NOCCA students while attending NOCCA (during the school year and during the summers) towards the School of HRT Work Experience Requirement of 600 work hours. NOCCA Students must verify their work experience with payroll documentation and a UNO-HRT Work Experience Form signed by the hospital industry supervisor. The hours will be verified by NOCCA staff. Students will present their verified documentation to UNO when they register for HRT 3002. In order to receive credit for HRT 3002, all students must complete 600 hours of work experience. Credit is only granted upon completion of the 600 hours.

#### \*HRT 2035 - Principles of Food Production Laboratory (1 credit hour waiver):

As a part of the articulation agreement, the School of HRT will waiver the 1 credit hour HRT 2035 - Principles of Food Production Laboratory credit for incoming NOCCA culinary arts students.

#### PURPOSE

The 30 hours are comprised of 13 credit hours for NOCCA courses and the opportunity of the remaining hours from the student's home high school. The course matrix, found in Appendix A, provides the specific articulations between NOCCA courses and UNO courses. NOCCA students who believe that they have the background appropriate for advanced standing in courses not included in this matrix will be provided the opportunity to attain advanced standing through the normal UNO process following admission to the program.
- NOCCA students must meet the admission requirements in effect for beginning freshmen (or transfer students, if applicable) at the time of application in order to be admitted to UNO and receive articulated credit as outlined in this agreement.
- NOCCA students must follow normal application procedures prior to admission to the University of New Orleans. As part of this process, students must submit an official transcript from the New Orleans Center for Creative Arts. Students must indicate on their application that they want credit for articulated NOCCA courses. Application materials are available online at <u>https://www.uno.edu/admissions/apply</u>.
- NOCCA students must interview/audition/present their portfolio confirming mastery in

order to receive credit for select courses.

- Students must receive a grade of A or B for NOCCA coursework and possess a Certificate of Artistry or Certificate of Achievement in their focus area in order to receive credit from UNO. Lab credit will not be awarded without corresponding lecture credit. A full-year course requires a grade of A or B in both semesters for credit to be awarded.
- Students will be awarded credit based on the course equivalencies and related requirements listed in this agreement (Appendix A). Course credit will be earned only and indicated with a "CR" on the UNO transcript. Thus, this course work will not be included in the cumulative grade point average calculations.
- Upon admission to UNO, students must have their NOCCA transcript evaluated by the UNO Office of Admissions. This should take place before the student registers to eliminate any problems with course credit.
- Degree and program requirements for NOCCA students who attend UNO and are granted course work under this agreement will be determined in the same manner as if their initial enrollment had been at UNO.
- NOCCA students pursuing the undergraduate degree at UNO must complete at least 25% of the semester credit hours required for the degree through instruction offered by UNO. One third of the credit hours required in the major, minor, or concentration must also be completed at UNO and can be included in the 25% degree requirement.
- Articulation of NOCCA credit is optional. A NOCCA graduate must inform UNO that s/he does wish to have their credit articulated.
- The President or College Counselor of NOCCA may recommend students for dual enrollment in UNO classes.
- This agreement applies to first-time freshmen and transfer students whose initial admission to UNO is for the Fall 2023 semester or after. This agreement does not apply to former NOCCA students whose initial admission to UNO occurred prior to Fall 2023.

#### **B. PROVISIONS FOR INSTITUTIONS**

- Faculty employed by NOCCA must meet stated professional credential requirements set forth by the Southern Association of Colleges and Schools Commission on Colleges which governs the acceptability of coursework taught and accepted for articulated credit by colleges and universities.
- NOCCA must submit a course portfolio, to include, but not limited to examinations and other course documents, for review by UNO annually or upon request.
- NOCCA will provide an opportunity for UNO faculty to observe course instruction.
- The institutions will engage in joint marketing efforts to promote the articulation partnership. Promotional efforts will include but are not limited to links on respective Web sites for placement of articulation agreements, information in the University Catalog, and transfer information in other school/college publications.
- NOCCA will promote the UNO-HRT program to prospective students within their programs.
- The institutions will encourage meetings between the UNO and NOCCA discipline faculty and administrators. The Provost/VP for Academic Affairs or designee at NOCCA will direct these meetings

 The institutions will discuss mutually beneficial collaborations among faculty and will seek opportunities for such collaborations to develop.

#### C. TERMS

This agreement shall be effective on \_\_\_\_\_\_ and shall continue until terminated by either party giving one-year written notice to the other party in order to protect students enrolled in the dual enrolment program.

Any changes to this MOU must be in writing and delivered by certified mail or by personal delivery to the person to be notified.

## Item F.5. University of Louisiana System's request for approval of System Universities' 2023-24 Promotions in Faculty Rank and Recommendations for Tenure.

#### **EXECUTIVE SUMMARY**

Annually each UL System campus submits recommendations for promotions in faculty rank and tenure. This year, 143 faculty members were recommended for promotion in rank, with 97 faculty members recommended for tenure.

With respect to promotion in rank, 47 faculty members across the UL System were recommended for promotion to the rank of Professor and 96 to the rank of Associate Professor. Our review suggests that the recommended faculty met all respective guidelines.

A total of 97 faculty members across the UL System were recommended for tenure and rationales were provided for the 5 faculty members to whom "early" tenure was recommended (i.e., before the six-year probationary term). In these cases, exceptions were considered based on outstanding performance and/or early tenure review was a condition of acceptance of employment. Board policy provides for such exceptions.

#### Item F.7. University of Louisiana System's request to revise *Board Rule, Chapter II.* Students, Section IX. Admission to Graduate Study.

#### **EXECUTIVE SUMMARY**

The UL System Graduate Deans collectively propose several changes to *Board Rule*, *Chapter II. Students, Section IX. Admission to Graduate Study* to reflect a holistic admissions approach and prioritization of accessibility and access to higher education followed by the institutions. These changes, which provide for more flexibility in admission standards, better reflect the experiences of System undergraduate students who are more likely to attend multiple institutions and transfer significant numbers of hours through initiatives such as Compete LA.

Proposed changes to A. Regular Admission, paragraph 2. (See attached file).

- Change from hold a baccalaureate degree from a regionally accredited institution.
- **Change to** hold a baccalaureate degree from a college or university accredited and recognized at the institutional level by the USDOE.

#### Justification:

The USDOE has determined that colleges and universities are no longer distinguished by regional accreditation. Accordingly, a policy adjustment is warranted.

Proposed changes to A. Regular Admission, paragraph 3. (See attached file).

- **Change from** requiring a baccalaureate degree with a minimum overall GPA of 2.50 on a 4.0 scale on all undergraduate coursework attempted or 2.75 on all upper division coursework attempted.
- **Change to** allowing multiple paths for an applicant to satisfy the minimum required overall GPA. Specifically, one of the following: a) requiring a minimum overall GPA of 2.5 on a 4.0 scale for the baccalaureate degree; b) a minimum overall GPA of 2.75 on the last 60 hours of undergraduate coursework; or c) a minimum overall GPA of 3.0 on at least 9 graduate credit hours. An exception to regular admission GPA may be granted if approved by the appropriate administrative unit of the institution.

Executive Summary August 24, 2023 Page 2

#### Justification:

Following holistic admissions best practices, GPA is but one factor in assessing potential for success in graduate education. Another factor to consider is that graduate applicants are adult learners often returning many years after earning the baccalaureate degree and often with significant relevant professional experience that warrants an institution's ability to consider for unconditional admission in exceptional cases.

#### Proposed changes to B. Conditional Admission (See attached file).

- **Change from** requiring a baccalaureate degree with a minimum overall GPA of 2.0 on a 4.0 scale in all undergraduate coursework attempted or 2.5 on all upper division coursework attempted.
- **Change to** allowing multiple paths for an applicant to satisfy the minimum required overall GPA. Specifically, one of the following: a) requiring a minimum overall GPA of 2.5 on a 4.0 scale for the baccalaureate degree; or b) a minimum overall GPA of 2.75 on the last 60 hours of undergraduate coursework.

#### Justification:

This proposed revision would align the conditional admission GPA requirements with the regular admission changes proposed above.

#### Proposed addition to G. Ineligibility (See attached file).

#### Justification:

The proposed addition would ensure that (1) institutions are required to secure official transcripts from all colleges and universities where graduate coursework has been attempted and (2) applicants inadmissible or ineligible to continue—for academic or disciplinary reasons—at any institution would be admissible at one of the institutions <u>only</u> through formal appeal.

#### CHAPTER II SECTION IX. ADMISSION TO GRADUATE STUDY

A. <u>Regular Admission</u>. To be eligible for regular admission, applicants must meet the following criteria:

- 1. Satisfy general admission requirements of the institution. These may include submitting a formal application, documents such as undergraduate <u>and graduate</u> transcripts, official reports on nationally recognized aptitude tests, and evaluations by recognized professionals in their field of interest, thereby demonstrating their potential for graduate study. When possible, interviews with the applicants should also be arranged.
- 2. Hold baccalaureate degrees from <u>a college or university accredited at the institutional level by</u> <u>an accreditor recognized by the USDOE</u> regionally-accredited institutions except for special approved programs which require only a specific set of pre-requisite courses and/or award the baccalaureate and master's degrees simultaneously. Credentials of international students will be evaluated individually by the institution. (Revised June 23, 2022)
- 3. Have earned a <u>baccalaureate degree with a minimum overall</u> GPA of 2.5 on a 4.0 scale on all <u>undergraduate work attempted</u> or <u>a minimum overall GPA of</u> 2.75 <u>on a 4.0 scale</u> on <u>the last 60</u> <u>hours of undergraduate course work all upper division course work attempted</u> or <u>a minimum</u> <u>overall GPA of 3.0 on at least nine hours of graduate credit</u>. An exception to regular admission GPA may be granted if approved by the appropriate administrative unit of the institution.

B. <u>Conditional Admission</u>. Applicants not qualified for regular admission may be granted conditional admission if they have earned a <u>baccalaureate degree with a minimum overall</u> GPA of 2.0 on a 4.0 scale <del>on</del> all <u>undergraduate work attempted</u> or <u>a minimum overall GPA of</u> 2.5 on <u>all upper division</u> the last 60 hours <u>of undergraduate</u> course work <u>attempted</u>.

- 1. Conditional status will be changed to regular status when a student earns a minimum of 12 semester hours of graduate credit (nine hours under the quarter calendar) with at least a 3.0 average and no grade lower than "C."
- 2. At the time a student completes 12 semester hours of graduate credit, if he and is not eligible for regular status, the student will be suspended from the degree program for a period of time determined by the institution. Readmittance shall be in accordance with the institution's established policy.

C. <u>Non-Degree</u>, <u>Transient</u>, or <u>Visitor Admission</u>. Each institution shall make provisions for nonmatriculating students. Not more than 12 semester hours of graduate credit earned while in a nonmatriculating status may be applied to a graduate degree.

D. <u>Provisional Admission</u>. Graduate students may be admitted on a provisional basis while in the process of obtaining required credentials. Students, who are admitted provisionally and subsequently are ineligible for admission or do not meet all requirements for admission within a reasonable time specified by the institution, shall have their registration canceled without refund of fees.

E.<u>Graduating Seniors – Concurrent Baccalaureate and Master's Program Enrollment</u>. Graduating seniors who have a minimum cumulative undergraduate GPA of 3.2 on all undergraduate work attempted may be allowed to register for graduate credit if they meet the following criteria:

1. Their admission into the program is approved by the graduate director/coordinator, their academic dean, and graduate dean.

2. The students lack no more than 30 semester hours to complete baccalaureate degree requirements.

3. The students may earn no more than 12 graduate credit hours while completing baccalaureate requirements.

4. Courses taken for graduate credit cannot be used to satisfy undergraduate requirements. The only exception to this rule is when a student enrolls in a combined curriculum program in which the faculty has approved graduate credit courses fulfilling undergraduate degree requirements. (Revised October 24, 2019)

5. Such students retain their undergraduate status until they are awarded the baccalaureate degree. Provisions of this section are not applicable to special programs that award the baccalaureate and master's degrees simultaneously.

6. While in the concurrent program, students shall maintain a minimum cumulative graduate GPA of 3.0.

F. <u>Entrance Examinations</u>. Admission requirements shall include evidence of potential for graduate study such as interviews, undergraduate record, record of prior experience in research, letters of recommendation, and work experience in relevant area. Scores from one or more nationally recognized aptitude measures may also be utilized.

G. Ineligibility. An applicant ineligible to register in any previously attended institution as a graduate student is not admissible for graduate study without formal appeal to the appropriate administrative unit of the admitting institution.
