## **EXECUTIVE SUMMARY**

Attached is a list of internal and external reports completed by various auditors since the August Board meeting. The internal audit reports are prepared based upon independent review of university departments and functions. The internal audits are designed to ascertain compliance with established policies and procedures, to evaluate operational efficiencies of business and management practices, and to determine adequacy of internal controls. The internal audits are conducted to provide management with recommendations and comments designed to improve the operations of university departments and functions. External audits are conducted in accordance with laws, regulations, or contracts. Also, included are internal audits that are currently in progress, and a Follow-up Time Table to ensure recommendations made in prior reports are implemented.
