- O Created the Athletics Diversity and Inclusion Council in the Summer of 2020, which has representation of both student-athletes and coaches from all 16 teams, along with both campus and athletics administrators.
- Launched a pilot Cultural Education & Mentoring (ROC Reaching Our Capacity) program for student-athletes in Spring 2019 to assist their matriculation into some of the cultural nuances of Utah. Program was developed in collaboration with a retired District Judge and a minority football alumnus.
- Started an evening training table meal 3 nights a week for all of our student-athletes in our West Stadium Center Club
  in January 2017.
- o In conjunction with our University Counseling Center, launched a Student-Athlete Mental Wellness Committee in 2017 to proactively address mental health concerns of our student-athletes.
- o Opened a "Fueling Station" for all student-athletes in our Strength & Conditioning Center in January 2016.

#### Development Successes:

- o Athletics had a record \$9.6M in gifts & pledges in fiscal year 2022, including over \$4M pledged towards a new indoor practice facility.
- o In November 2019, the athletic department received a \$1.44M gift for endowed scholarships for student-athletes who are engineering majors. This is the largest endowed scholarship gift ever for Utah State Athletics.
- Fiscal year 2019 set a fundraising revenue record of \$6.9M, marking the second time in the past three fiscal years the record has been eclipsed. In fiscal year 2017, the mark was established at \$6.4M, which eclipsed the previous annual fundraising mark of just over \$5M.
- Rebranded the fundraising arm of Athletics in 2017 with the creation of Aggies Unlimited, which unified all athletics giving under one centralized program.
- Secured \$10M+ in gifts & pledges to the West Stadium Center between August 2015 and December 2016, including a \$3M gift from one individual.

#### Financial Growth & Fiscal Responsibility:

Managed budget growth from \$28M in fiscal year 2016 to \$40.9M in fiscal year 2023 due to new revenue streams and the growth of existing revenue streams.

For fiscal year 2022 Athletics ended the year with a surplus of revenues over expenditures. This marks the fifth time in six years that Athletics has balanced the budget, which had not been accomplished in the prior ten years.

#### Athletics Facilities Improvements:

- o In the Spring of 2022 plans were announced for a new 110,000 square-foot, \$32M indoor practice facility, which will also house a new golf practice facility, along with locker rooms and coaches' offices for soccer.
- O Upgrades in Maverik Stadium in Spring 2022 included new turf on the field and over 4,000 new chair back seats in the west side lower bowl.
- o In the Fall of 2021, the natural grass field in softball was replaced with a turf field.
- A new student-athletes' lounge in the Laub Complex was completed in Summer 2021.
- O Total renovation of the Football locker room in the summer of 2019.
- o A new Gymnastics Practice Facility was completed in 2017 that more than doubled the size of the previous facility.
- o The Maverik Stadium West Center opened in August 2016 at a cost of \$36M. It includes 20 suites, 740 club seats, which includes a club dining area that is also used to host our student-athlete training table during the week, 20 loge boxes, and a state-of-the-art press box.
- A major video board upgrade was completed in Summer 2016 to include: 2 football boards, a softball board, and a soccer board.

#### Other Revenue Generation Successes:

- o In the Summer of 2022 renegotiated the multimedia rights deal with Learfield that will result in an average increase of over \$900,000 per year over the life of the contract.
- o The Nike apparel & footwear deal was renegotiated and signed in February 2020, which more than doubled the annual amount of product that is provided free of charge to Aggie Athletics.
- Moved from a third-party outbound ticket sales team to an in-house group that has more than doubled our outbound
   ticket sales revenue in the first year.
- Entered a new partnership with the Larry H. Miller Entertainment Group to be the flagship station for Aggie Athletics, which has expanded our affiliate station coverage and increased sponsorship revenue opportunities.

#### New Endeavors:

- o In Spring 2017, introduced the branding slogan "This Is Our (U) State", which was adopted as a University-wide campaign throughout the state of Utah.
- Starting with the 2015-16 academic year, my family began having every student-athlete in our home for dinner at least once per academic year in an effort to get to know them better on a personal level.

- o Selected to fill the Mountain West Division I Council spot for Spring of 2022.
- Chosen as the only FBS Athletic Director to testify on the subject of "Compensating College Athletes" on Sept 15,
   2020 to the United States Senate Committee on Health, Education, and Labor (HELP).

- o LEAD1 (formerly D1-A) Institute Faculty Member presenting to aspiring Athletic Directors each July since 2015.
