Explanation/Justification to Appoint Dean of the College of Nursing

Dr. Sue Westbrook has continued to hold the title of, and operate as, the Dean of the College of Nursing since being promoted to the role of Provost and Vice President for Academic Affairs in January of 2018. Since that time, the University has posted the position twice using additional funds to advertise outside of normal venues, including a minority nursing journal and the ANCC Syllabus. The first search, conducted shortly after Dr. Westbrook's promotion, resulted in a failed search following the interview cycle with only two applicants. The second search gathered only two applicants, and was opened for a second period of time with no additional applicants. One applicant from the second search has since gained employment in Texas, and the second applicant is an internal candidate currently serving as Department Head for Nursing. This second candidate, Dr. Raquel Engolio, has the requisite skill set and demeanor to serve as the Dean of the College of Nursing. We are requesting to appoint Dr. Engolio as Dean of the College of Nursing effective January 9, 2023. The timing of this request is based on the upcoming CCNE reaffirmation of accreditation for the baccalaureate and master degree programs in nursing. The programs will be site-visited during the Spring 2023 semester, and we would like to have a Dean in place at the beginning of the Spring semester. We do understand that final ratification of this position will need to be submitted for the February 2023 UL System Board meeting.

Southeastern Louisiana University requests approval to appoint Dr. Claire Procopio as Interim Dean of the proposed College of Honors and Excellence, effective March 1, 2023, at an annual salary of \$145,000. Staff approval of Southeastern's request to create a College of Honors and Excellence was granted by the UL System on January 19, 2023 and is under consideration by Regents staff at this time. The College will house the University Honors program and the initiatives of the Center for Student Excellence. Dr. Procopio will occupy the position vacated by Dr. Lorett Swank, Chief Student Success Officer, who is resigning March 1. That position will be retitled as Dean of the College of Honors and Excellence.

Dr. Procopio has been a member of the Southeastern family since 2005, and has served as Honors director since 2016. A full professor in the Department of Communication and Media Studies, Dr. Procopio was the recipient of the President's Award for Excellence in Teaching in 2017 and the L.E. Chandler award for service to students in 2021. Dr. Procopio is a member of the graduate faculty whose research focuses on effective communication within colleges and universities. She was instrumental in developing program review standards for the National Communication Association (NCA) and served on the NCA Tuning Project to develop learning outcomes for the field. As Honors Director, she quadrupled enrollment, implemented a mentoring program, founded the Honors Student Association and Ambassador programs, and launched the university's first living-learning communities.

I am confident that Dr. Procopio will provide strong leadership for the college during this interim period. A national search to fill the dean position on a non-interim basis will be conducted in accordance with University of Louisiana System policy.

I respectfully request that you place this item on the agenda for the February 23, 2023 meeting of the Board of Supervisors.
