MINUTES BOARD OF SUPERVISORS FOR THE UNIVERSITY OF LOUISIANA SYSTEM SPECIAL MEETING April 25, 2024

A. Call to Order/Roll Call

The Board of Supervisors for the University of Louisiana System met for a Special Meeting on Thursday, April 25, 2024 at 1:02 p.m. The meeting was held in the Louisiana Purchase Room of the Claiborne Building, 1201 North Third Street, Baton Rouge. Chair Jimmy Clarke called the meeting to order.

B. Invocation

Mr. Joe Salter opened the meeting with an invocation.

C. Report of McNeese State University Presidential Search Committee

System President Rick Gallot gave a little background concerning the search. He said that in February the Committee held its first meeting on McNeese State University's campus to gather input from the campus and constituents concerning desirable qualities for the presidency.

On April 4, the Committee met in Baton Rouge to review applications and select semifinalists for interview. Four candidates were chosen for interview: Dr. Andy Benoit, Jr., Dr. Shadow Robinson, Dr. Wade Rousse, and Dr. Allen Vital.

On April 16-17, the four semifinalists were interviewed by the Committee on the campus, where they also met with students, staff, faculty, alumni, and community members. On April 17, the Committee selected two finalists for interview by the Board, Dr. Andy Benoit, Jr. and Dr. Wade Rousse.

At the conclusion of the second Executive Session, the Board will return to Open Session for discussion and a vote.

E. Candidate Interviews

Dr. Wade Rousse

Dr. Wade Rousse was introduced to the Board, and he invited his wife Angela Rousse to introduce herself. Dr. Rousse made an opening statement. After several questions from Board members, upon motion of Ms. Dunahoe, seconded by Mr. Busada, at 1:41 p.m., the Board unanimously voted to adjourn to Executive Session.

At 2:31 p.m., upon motion of Ms. Dunahoe, seconded by Mr. Busada, the members reconvened in Open Session.

Dr. Andy Benoit, Jr.

Dr. Andy Benoit, Jr. was introduced to the Board, and he made his opening statement. After questioning by Board members, upon motion of Ms. Dunahoe and seconded by Ms. Stokes, the Board adjourned to Executive Session at 2:57 p.m.

At 3:56 p.m., upon motion of Mr. Romero, seconded by Ms. Dunahoe, the Board reconvened in Open Session.

F. **Deliberations**

After returning from Executive Session, Dr. Clarke asked for comments from the Board. Upon motion of Dr. John Noble, Jr., seconded by Ms. Bailey Willis, the following recommendation was made:

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors for the University of Louisiana System hereby recommends that Dr. Wade Rousse be appointed as President of McNeese State University and hereby authorizes UL System President Rick Gallot and Board Chair Jimmy Clarke to negotiate the terms of appointment and execute an offer of employment on behalf of the Board.

A roll call vote was taken. The following affirmative roll call vote was recorded: Mr. Busada, Dr. Clarke, Ms. Dunahoe, Ms. Lethermon, Dr. John Noble, Jr., Mr. Peterson, Mr. Robinson, Mr. Romero, Mr. Salter, Mr. Stevens, Ms. Stokes, and Ms. Willis. The resolution passed.

G. Introduction of President of McNeese State University

Dr. Wade Rousse and his wife were escorted back into the auditorium to a standing ovation. Dr. Rousse expressed his thanks to the Board for selecting him and said it is a privilege to serve McNeese State University as President.
