Southeastern recently conducted a national search to fill the position of Dean of the College of Arts, Humanities, and Social Sciences. A broad-based Search Committee evaluated applicants for the position in accordance with System policy. The Search Committee included the assistant dean, an academic department head, a director, faculty, and a student representative, all from the College of Arts, Humanities, and Social Sciences. The Committee was chaired by the Dean of the College of Honors and Excellence. The Committee received forty-six qualified applications for the position; six applicants were selected to participate in virtual (Google Meet) interviews, and the top three candidates were invited for on-campus interviews. Please find attached a copy of the Search Committee meeting minutes, a copy of the memo from the Search Committee Chair to the Provost concerning the Committee's recommendation (candidates' strengths and weaknesses), and a copy of the position advertisement published online in The Chronicle of Higher Education (diversity boost), the American Conference of Academic Deans' website, The Advocate/Times Picayune/Nola.com, and Southeastern Louisiana University's website.

Southeastern is pleased to request permission from the University of Louisiana System Board of Supervisors to appoint Dr. Jeffrey Wright as the Dean of the College of Arts, Humanities, and Social Sciences at an annual salary of \$170,000, effective January 2, 2025.

Dr. Wright is a tenured Associate Professor of Music, who has served as Department Head of Music and Performing Arts since 2018. He has cultivated strong relationships not only within The College of Arts, Humanities, and Social Sciences but across campus. I am confident that Dr. Wright is the right choice for leading our College of Arts, Humanities, and Social Sciences now and well into the future.

Below is an account of the actions of the Search Committee for Dean of the College of Arts, Humanities and Social Sciences. The committee began with Dr. Golding's email appointing committee members on August 8 and ended with a final letter from the committee to Dr. Golding on November 11, 2024.

The job position (R-1645) was posted on August 14, 2024, and ran for 30 days locally and nationally appearing on higheredjobs.com, *The Chronicle of Higher Education* (diversity boost), the American Conference of Academic Deans' website, and *The Advocate/Times Picayune/Nola.com*. The advertisement assured consideration for applications received by September 25, 2024.

¹ The undergraduate representative did not attend meetings or participate in the process. Student input was thus gathered via small student groups meeting with each candidate as part of the oncampus itinerary.

Following the priority deadline, Human Resources assessed forty-six applications as meeting the required qualifications for the position. These candidates returned completed applications with all of the required supporting documents.

The committee met September 27, 2024, to review qualified applicants. Prior to the meeting, committee members created a rubric based on the requirements listed in the job posting and used it to formulate their individual assessments of candidates. At the meeting on the 27th, the committee members shared their assessments of the candidates and unanimously selected six to invite for virtual interviews. These selections were based on the respective strengths and weaknesses displayed through the application materials and the job requisition. Dr. Claire Procopio shared a draft list of questions for use during the virtual interview which the committee then augmented, amended, and revised. A common set of questions was adopted and used at each virtual interview to ensure that all interviewed candidates were asked the same questions in the same format. Group emails and the use of a shared drive for electronic documents allowed the committee to develop material and communicate between meetings.

All six virtual interviews were held on October 4, 2024. The candidates in order of interview are listed below:

- Dr. Jeffrey Wright
- Dr. Paula Varnado-Sullivan
- Dr. Jonathan Swarts
- Dr. Eric Rasmussen
- Dr. Margaret Ferguson
- Dr. Erin Dupuis

The committee chair asked the committee members to return to their rubrics, evaluate each of the six interviewes in light of the new information gleaned via the virtual interviews, and to rank the candidates from first to sixth via an online poll prior to the next meeting. At the next meeting on October 8, 2024 the committee reviewed the rankings and selected candidates to invite to oncampus interviews. The discussion was based on perceived strengths and weaknesses of each candidate and the posted job requisition. After the meeting, the committee unanimously voted to invite three candidates for on-campus interviews.

The candidates invited to interview on campus are listed below in the order in which they were interviewed:

- Dr. Jeffrey Wright, October 22, 2024
- Dr. Jonathan Swarts, October 28, 2024
- Dr. Margaret Ferguson, October 30, 2024

While on campus, each candidate met with the search committee, Department Heads from the College of Arts, Humanities and Social Sciences, delivered a public presentation open to the entire campus; ate lunch with members of the search committee, met separately with both the University President and Provost and Vice President for Academic Affairs, and met with deans and staff from liaison units and students from the College of Arts, Humanities and Social Sciences.

Members of the campus community who participated in any part of the on-campus itinerary for any candidate were sent an open-ended questionnaire asking them their role on campus and their perceptions of the strengths and weaknesses of each candidate with whom they interacted. Twenty-eight responses were received. The full comments received and a summary document were shared electronically with committee members.

The Search Committee met November 4, 2024 to debrief following the last candidate's on-campus visit. The committee worked as a group on a shared document assessing the strengths of each candidate and any aspects of the role where their background or approach might not fully align with the college's needs. The chair reminded members of the committee that the charge was not to rank the candidates but rather to provide clear strengths and weaknesses for each finalist. The committee chair also contacted the references for the two external candidates receiving 5 references via phone interview and one via email – three for each external applicant using the same list of five questions for each reference checked to ensure uniformity. The references were posted for committee members on the committee's shared electronic drive. Human resource policy does not require reference checks for current employees.

All committee members participated in the completion of the candidate assessment letter. On November 7, 2024 an electronic version of the final letter with links to the candidate evaluation rubric, candidate itineraries, open-ended survey results from campus stakeholders, interview questions used, references' responses, and an assessment of the committee's thoughts on the strengths and weaknesses of each candidate was shared with the provost and president. A hard copy was printed which was signed by each committee member and delivered to Drs. Wainwright and Golding on November 11, 2024.

Subject: Summary of Findings from the AHSS Dean Search Committee

Dear President Wainwright and Provost Golding,

On behalf of the AHSS Dean Search Committee, I am pleased to provide an overview of our evaluation process and findings. The search committee of 11 representatives from the college[1] began with an initial pool of 46 candidates, pre-screened by Human Resources as meeting the advertised qualifications for the position. We individually reviewed the applications against a rubric based on the position description, met, and narrowed to six candidates for virtual interviews. Following the virtual interviews, the six candidates were ranked by each committee member using the rubric once again allowing the committee to identify three finalists for on-campus interviews. Each on-campus visit included sessions with department heads, liaison units, students, a public presentation to faculty and staff, and a formal interview with the committee. Feedback was gathered using an open-ended survey sent to stakeholders who attended an on-campus meeting. That feedback provided additional insights on each candidate's strengths and potential alignment with the college's needs. References were also checked using a standard list of questions.

Based on the process and input outlined above, the committee finds each finalist potentially acceptable and presents all three in alphabetical order for your consideration. However, our analysis below highlights the strengths and weaknesses of each candidate in relation to the role's requirements and how closely their skills and experiences align with the position's core qualifications.

Dr. Margaret Ferguson

Dr. Ferguson is regarded by the committee as one of the best-qualified candidates, demonstrating the strongest potential for effective advocacy on behalf of AHSS due to her substantial experience and gravitas. Throughout the interview process, she exhibited an impressive command of student success research and student performance data specific to our institution, including insights on DFW rates, challenges

in converting dual enrollment students to full-time undergraduates, and challenges with graduation rates at the university and college level. Her prior experience in leading restructuring efforts as IUPUI became IU-Indianapolis and implementing reductions in force would be valuable as we prepare for the enrollment cliff. Based on her eight-year experience as a Senior Associate Vice Chancellor for Academic Affairs she offered concrete strategies for resource deployment and avoiding program proliferation that could be useful if university funding declines. Dr. Ferguson's publication record is also the strongest of the three finalists, and she has a deep familiarity with research not only within her own field but also on topics relevant to higher education professional development and student success. The committee was particularly impressed by her knowledge of faculty culture and her success in implementing inclusive tenure and promotion policies that have served as a national model for other institutions. Her commitment to public-engaged scholarship aligns well with the university's mission to serve as an educational and economic engine for the region. Additionally, she demonstrated extensive knowledge in accreditation, curriculum development, and program review including experience as Accreditation Liaison Officer to the Higher Learning Commission. Her background in political science would complement the college's social science offerings, and she has a passion for the arts from attending theater to throwing pottery. Her connections to the humanities were less evident.

However, Dr. Feguson's preference for hybrid over fully online education could present challenges in expanding online program options. She also has less experience with fundraising and grant-securing than the other candidates. There were mixed perceptions among committee members regarding her interpersonal style; while some felt connected to her through personal disclosures, others found it more difficult to establish rapport.

Dr. Jonathan Swarts

Dr. Swarts stands out as the only finalist with dean-level experience serving as dean of an honors college and as the creator of the university college focused on freshman success at his current institution. His career path, which includes serving as everything from an adjunct faculty member to a professor to a department chair to an associate vice chancellor for academic affairs, has provided him with comprehensive knowledge of the academic pathway. He demonstrated a strong commitment to student success, including expertise in intrusive advising and a vision for incorporating micro-credentialing within the general education curriculum - two initiatives AHSS is interested in embracing. His understanding of the business side of higher education, along with a proven ability to increase enrollment with minimal additional resources,

could be advantageous for the college in seeking to build enrollment without additional resources. Dr. Swarts has also successfully enhanced diversity within student enrollment at previous institutions and emphasized the importance of achieving a critical mass of minority students to foster belonging on campus. He has successfully raised funds for student-centered initiatives and done so through forging strong community partnerships that offer not just money but connections and workforce experiences to students. He is an active scholar with an impressive list of books, scholarly articles, and research presentations. With experience in curriculum and program development and a history of shared governance, he offers a balance of administrative and academic expertise. The committee unanimously agreed that Dr. Swarts has affable interpersonal skills, especially in smaller groups, though he may lack the assertive presence sometimes needed in public settings.

The committee noted, however, that Dr. Swarts appeared taken aback by discussions about potential budget cuts in Louisiana, which may indicate a need for greater adaptability. Additionally, he relied on a limited pool of examples during his interviews, which contrasted with Dr. Ferguson's more varied responses, perhaps indicating less breadth of experience.

Dr. Jeffrey Wright

Dr. Wright's greatest strength lies in his well-established relationships within both the campus and the broader community. This strength was evident in the large turnout for his public presentation. He has been instrumental in the university's general education overhaul and has strong relationships with the student engagement office, development and finance offices, and other units that frequently collaborate with AHSS. Dr. Wright also demonstrated a nuanced understanding of the college's needs and a realistic view of the change fatigue currently affecting the campus. His fundraising experience is particularly notable, as he has secured the largest grant among the finalists—a \$1.9 million donation to renovate a recital hall at his previous institution. He has also secured local funding for projects on our campus, including an overhaul of the orchestra pit cover in Pottle and support for international students to pay for TOEFL examinations increasing international students majoring in music. His knowledge of the arts and humanities is strong, and he is recognized for his collaborative and inclusive leadership style.

As an insider, however, Dr. Wright may lack the fresh perspectives that an external candidate could bring. His administrative experience is limited to a few years as department head, compared to the wealth of dean- and academic affairs-level

experience among the other candidates. Additionally, his publication record is the weakest of the three finalists.

While the committee does not rank the candidates, this analysis suggests that the candidates differ in the number and ways they fulfill the qualifications detailed in the position description. We hope that this comprehensive overview assists in selecting the best candidate for the college's future, and we are available to provide any further insights as needed.

The University of New Orleans (UNO) requests approval to appoint Dr. Steven Johnson as Interim Dean for the College of Science and the Robert A. Savoie College of Engineering. At the December 5, 2024, University of Louisiana System Board of Supervisors meeting, members approved a temporary plan to restructure the university. Part of this plan called for the consolidation of colleges and to reduce the number of Academic Deans from four to two.

To ensure the campus community was involved in the process of the consolidation plan, three town hall sessions were held over the course of two days providing stakeholders the opportunity to weigh in on future planning. Additionally, a survey was distributed to all campus faculty and staff requesting their recommendations as to who they believed could lead the consolidated colleges for the interim period.

The University of New Orleans (UNO) requests approval to appoint Dr. Randy Kearns as Interim Dean for the Henry L. Berstein College of Business Administration and the College of Liberal Arts and Education. At the December 5, 2024, University of Louisiana System Board of Supervisors meeting, members approved a temporary plan to restructure the university. Part of this plan called for the consolidation of colleges and to reduce the number of Academic Deans from four to two.
